







POLITICAL PUBLIC OPINION OF MONTENEGRO

Sample

•The sample is representative for all citizens over 18 years old. It was conducted in all Montenegrin municipalities.

•Total of 1003 of respondents participated in the research survey.

•Sample: double stratified with random selection of respondents within defined enumeration areas.

•Standard statistical error is +/-3.1 % for the appearances with incidence of 50% with interval of trust of 95%.


•Post stratification was performed by gender/sex, age and national affiliation.

•Research was conducted in the period from 8 to 21 June, 2016.

•Research is supported by NATO Public Diplomacy and US Embassy to Montenegro.




In general, would you say that Montenegro is on the - %






Montenegro is on the: Trend - %






In your opinion, should Montenegro access the European Union? - %






Support to the EU: TREND (%)




If you should vote on membership of Montenegro in NATO, you would vote -%?














Do you believe that, regardless of your opinion, Montenegro will become a NATO member? %






Do you believe that, regardless of your opinion, Montenegro will become a NATO member? % TREND








Which countries should Montenegro rely on in terms of foreign policy? %






Which countries should Montenegro rely on in terms of foreign policy – SUM to a great extent/completely - %






Montenegro has restored its independence with referendum 10 years ago. From this time perspective, how do you rate that event - %


CONFIDENCE IN INSTITUTIONS – SUM high confidence and mostly confidence %










How do you assess the signing of the Agreement on the establishment of the so-called Government of electoral trust - %





How do you assess the signing of the Agreement on the establishment of the so-called Government of electoral trust according to the party supporters : positive vs. negative %






The main goal of the newly formed government is to make election process better and to stop election irregularities that were discussed. Do you think that the government will succeed in that? %






The newly formed Government will improve the election process - % of those who agree by political parties






Do you support the entry of parties SDP / URA / DEMOS / POSITIVE in the Government - %


